



# AVC Girls Player Contract 2011-2012 Season

You/Your Daughter has qualified to play on a USA Volleyball Team for The Academy for Volleyball Cleveland (AVC). This is a binding contract between the player, the player's parents, and AVC. By signing this contract you agree to the terms outlined below.

### Commitment to AVC

- I understand that I am committing as a player to AVC and that I cannot play for any club other than AVC for the 2011-2012 season.
- I understand that AVC selects the most appropriate and available coach(es) for my team, age group, and level of competition (National, Elite, American, Regional) and that a specific coach for my team is not guaranteed.
- I commit to attend all practices and tournaments unless prior agreements were made with the coach.

### Club Fees and Payment Schedule

- I agree to pay the club fee according to the fee schedule below and pay any applicable fees associated with a payment plan.
  - The National Player Fee for the 2011-2012 Season is \$2200
  - The Elite Player Fee for the 2011-2012 Season is \$1800
  - The American Player Fee for the 2011-2012 Season is \$1400
  - The Regional Player Fee for the 2011-2012 Season is \$1300
  - The 10U and 11U Player fee is \$900 (10U) and \$1000 (11U) respectively/
- I agree to pay an initial deposit of 1/2 the total fee that must be received by December 1st 2011 to reserve my position in the club.
- I agree to pay the remaining balance by January 8th, 2012. Players run the risk of losing their spot on the team if the club fee is not received in full by January 8th, 2012, unless they are on an approved payment plan.
- I understand that no refund of fees paid will be given for players leaving the team voluntarily or involuntarily. Fees may be refunded for medical and unusual situations (minus registration fees, uniform costs) as determined by the Club Director. Fees may be refunded in full if a replacement player pays the full fee.
- Payment plans are available on a case by case basis and must be requested from and approved by the Club Director. The club fee can be broken up into monthly installments. A convenience fee will be added to each installment.

### Conduct and Playing time

- I have read the AVC Player Code of Honor and Parent Code of Conduct located on the AVC website and agree to abide by it or face participation restrictions or even club expulsion for violating any club policy.
- I understand that playing time is solely the coach's discretion and that the payment of club fees does not guarantee playing time in tournaments.
- I grant AVC permission to use the player's name, photos or likeness for promotional and marketing purposes.
